Under the general supervision of the Project Director, the Program Director will be responsible for implementing and accomplishing all objectives of the program grant; developing program design, overseeing implementation and evaluation; hiring, training, supervising and evaluating program administrative, academic and residential staff; negotiating the housing contract for summer residential component, securing classroom and office space for staff and students; completing reports required by University and U.S. Department of Education; writing proposals for continued program funding and summer meals through government agencies; managing budgets.

Master's Degree in Science, Math, Engineering or other related field; minimum five (5) years experience in the following: designing, managing, directing and administering math, technology, engineering or science educational programs, hiring, training, supervising and evaluating staff, developing partnerships and establishing relationships among K-12 administrators, community college personnel, university faculty and staff, public sector, corporate community and community based organization, direct professional experience working with low-income, first generation, multi-ethnic populations; knowledge of the purpose of TRiO programs, preferably Upward Bound or Upward Bound Math & Science; ability to communicate effectively with people of diverse cultural backgrounds; must be familiar with target area schools; demonstrate sensitivity to the needs of economically and educationally disadvantaged participants; excellent written, oral and interpersonal skills; ideal candidate will have educational and/or economic background similar to the target population and who has overcome the barriers confronting low-income, first generation college students.
